Mr. Walther transferred these securities to the Walther-Stockton 2013 Family Trust immediately after grant.

Following the transactions reported on this Form 4, Mr. Walther held (a) 60,506 shares of the Company's common stock, (b) 117,836 performance-vesting restricted stock units, each representing the right to receive one share of the Company's common stock, and (c) 31,146 time-vesting restricted stock units, each representing the right to receive one share of the Company's common stock.
