Mr. Corti transferred the shares to the Robert J. Corti Revocable Trust, of which Mr. Corti and his spouse are co-trustees, immediately after grant.
- Following the transactions reported on this Form 4, Mr. Corti held, through the Robert J. Corti Revocable Trust, (a) 62,948 shares of the Company's common stock and (b) 3,208 restricted stock units, each representing the right to receive one share of the Company's common stock.
